- 4. The bidder should quote the total price for each item and including of packing and forwarding, any other charges if any. The VAT extra should be mentioned in percentage.
- 5. The bidder should submit **EMD** of an amount of **Rs.10,000/-** in the form of Demand Draft in favour of Director, NIT Silchar payable at Silchar along with the bid. The offers without Earnest Money Deposit (EMD) shall be outright rejected.
- 6. It is not binding for the bidding agency to quote for all the items.
- 7. The rate should be quoted separately against each make of battery excluding VAT.

- 8. Warranty period of SMF Battery for UPS shall be 2(two) years on-site replacement.
- 9. The quotation shall be in sealed envelope super scribing "Quotation for supply of SMF Battery with buy-back offer" addressed to "The Purchase Officer, NIT, Silchar-10 & shall be sent/submitted at Purchase Section, NIT Silchar on or before 20<sup>th</sup> becember, 2016 up-to 01.00 PM and quotation shall be opened on the same day at 03.30 PM in Purchase Section, NIT Silchar.
